This request to review and reaffirm previous action on the Planned Unit Development (PUD) Application and Development Plan, Amendments of the Town of Tyre Zoning, and Site Plan Review are forwarded for review under Section 239 of the General Municipal Law because it is within 500 feet of State Route 414 and Agricultural District #6.

GENERAL INFORMATION & ANALYSIS

These are at the same applications/actions as this Board took action on in August and September of this year as well as previous actions. At the September 10, 2015 meeting this Board recommended: 1) that the Town of Tyre accept and approve the Application for Planned Unit Development, and the proposed Development Plan for Development of a Resort and Casino on Town of Tyre Tax Parcel 12-1-36, 2) adoption of proposed Local Law #5 of 2015, that adds clarifying language to the Town of Tyre Zoning Law regarding Planned Unit Development, and amends the Town of Tyre Zoning Map such that Tax Parcel 12-1-36 be Zoned Planned Unit Development (PUD) for the purposes of the development of a Resort and Casino, and 3) reaffirms its approval of the Site Plan for Lago Resort and Casino as reviewed by this Board on August 13, 2015.

Since that time the Town Board of Tyre, acting as lead agency, at a meeting on October 1, 2015 passed a resolution of findings and made the determination that "the Action will not have significant adverse environmental impact and issues a Negative Declaration, and that the Board will not require preparation of an environmental impact statement with respect to the Action."

As there has been additional documentation added to the items reviewed and considered by the Town of Tyre Board as part of the SEQR process, this Board has been asked to reaffirm its recommendations regarding the Planned Unit Development (PUD) Application and Development Plan, Amendments of the Town of Tyre Zoning, and Site Plan Review.

RECOMMENDATION

The Seneca County Department of Planning and Community Development advises the Seneca County Planning Board to in light of the additional documentation that has been made a part of the State Environmental Quality Review process to reaffirm its recommendations of: 1) acceptance and approval of the Planned Unit Development (PUD) Application, 2) acceptance and approval of the Development Plan, 3) adoption of the Zoning Amendments, and 4) approval of the Site Plan Review.
