The purpose of the meeting was to hear public comment on the 2016 Town of Tyre Preliminary Budget and the 2016 Tyre Water District #1 Preliminary Budget; and to hear public comment in considering the contracting with the Magee Volunteer Fire Department, Inc. for fire protection to be furnished to the Tyre Fire Protection District.

Supv. McGreevy - have had roll call - quorum present - meeting called

to order at 7:30 P.M.

Supv. McGreevy congratulated Elizabeth Sutterby - Town Clerk, James Rogers - Councilman, Kenneth Sutterby - Councilman, Cathy Doyle - Tax Collector and Larry Mills - Town Justice. The Town of Tyre was the winner as a result of these people being elected. The people of the Town of Tyre have clearly spoken.

Financial - Budgets

Councilman Thomson made a motion, seconded by Councilman DelPapa and carried, that the Public Hearing be opened at 7:35 P.M. for the purpose of hearing any person or persons in favor or against any item or items contained in the 2016 Town of Tyre Preliminary Budget and the 2016 Tyre Water District #1 Preliminary Budget.

John Paul Partee, 2107 St. Rt. 318, questioned where the money came from to budget over a 10% increase in salaries and questioned the retirement figure in the budget. The Bookkeeper explained the money came from Capital Reserve.

Planning Board members are supposed to be paid as they are responsible

for decisions they make.

Mr. Partee asked how the Board could justify a 10% increase in justice salaries. The Bookkeeper explained that employee wages in the Town of Tyre are lower than other towns. Councilman Aceto replied the work load is not the same as it used to be.

The Supervisor stated that Mr. Partee's comments are so noted.

Supv. McGreevy asked if there were any other positive or negative com-

ments on the Preliminary Budgets. None were forthcoming.

The proposed amount to be paid to the Magee Volunteer Fire Department, Inc., is \$107,958.00 with an additional \$2400.00 to be paid for the use of

the public section of the fire department building.

Supv. McGreevy asked if there were any comments in regard to the proposed contract with the Magee Volunteer Fire Department. The Supervisor again asked if there were any comments. None were submitted.

Ms. Jenkins will be willing to fill that position. Ms. Jenkins also stated she didn't have any changes to be made in the Shelter Agreement. Supv.
