The Comprehensive Plan Committee Meeting Was Cancelled.

The regular monthly Town of Tyre Planning Board meeting was called to order at 7:30 PM by Vice Chairman Alan Smith.

The minutes of the meeting held on December 28, 2010 were approved as written on a motion of Larry Kesel seconded by Neil Worden.

New Business:

Tyre Planning Board members agreed that the slate of officers for the year 2011 be unchanged from that of 2010. Robert Seem will serve as Chairman, Alan Smith will serve as Vice Chairman and Ronald McGreevy will continue to serve as Secretary. Motion made by Neil Worden seconded by Larry Kesel. Carried unanimously. Secretary McGreevy will provide a copy of the 2011 Tyre Planning Board membership and slate of officers to Tyre Town Clerk Elizabeth Sutterby.

Board members very briefly reviewed the Jan./Feb. 2011 issue of *Talk of the Towns and Topics* magazine.

Old Business:

Planning Board member Larry Kesel gave an update on the development of the Tyre website. www.tyreny.com was officially launched on January 24, 2011. This new website includes a list of all town officials complete with their contact information, a page for local events and activities, a profile and detailed history of the Town of Tyre, a directory of in-town businesses and organizations, an economic development section as well as a number of downloadable forms. There are also many helpful links to Seneca County and New York State websites provided. Much more information is planned to be added in the coming months.

Planning Board members briefly continued discussion of *Commercial Kennels/Commercial Pet Breeding Facilities*. Board member David Kain discussed contacting the American Veterinary Medical Association for relevant information.
