CHA / Bryan Bouchard - Dunkin' Donuts.

Chairman Seem requested the following information be shared with Dunkin' Donuts representatives. Although the property is not listed in any Historical Registry it represents local history as far back as the 1800's regarding Dr. Thomas C, Magee and Magee's Corners named after him. A Historical marker would be greatly appreciated identifying his local contributions during his lifetime from 1780 to 1860. Bryan will research.

ECC Technologies Broadband Feasibility update:

Chairman Seem announced that the Town Board passed a resolution to proceed and authorize payment to finance the Broadband Feasibility study in the Town of Tyre at their May monthly meeting. Good possibility we may see presentation from ECC Technologies at the June Planning Board meeting.

#### **NEW BUSINESS:**

Zoning Law Update:

Adam Cummings and Tom Blair gave an overview of the extreme importance of the proposed Zoning Law review and update. Recommended that to provide greater flexibility for agriculture, residential structure plus defining parameters for commercial uses must include a committee of representatives from the Town. Adam Cummings, Tom Blair, Bob Seem and Supervisor Ron McGreevy will present proposed size of this committee, candidates to the Town Board at their June meeting. The old antiquated Zoning Law must be updated, revised and brought up to the Twenty-First Century real world standards and expectations.

Chairman Seem announced that Henry Bickel was approved by the Seneca County Board of Supervisors to fill the empty seat on the Seneca County Planning Board vacated by Larry Kesel last year. The Town of Tyre has reinstated their representation on the County Planning Board. Hank will remain on the Town of Tyre Planning Board in addition to his new duties at the County.
